ORDER

The present petition came up for hearing today on 02.11.2022. None present for petitioners. Ld. Counsel for the respondents present. Ld. Counsel for respondents stated that petitioners are not attending the court since long and as such petition may be dismissed in default of non prosecution on behalf of petitioners. Perusal of order sheet of the case file reveals that neither the petitioners nor his counsel have been attending the court continuously since 25.05.2021 and today i.e. 02.11.2022 also they have not caused appearance in the court, from which it is inferred that the petitioners have lost interest to prosecute the case and further proceedings in the matter would result in wastage of the precious time of Court. Therefore, the present petition is dismissed in default for non-prosecution on behalf of petitioners. The interim order issued by this court, if any, shall stand vacated. The case file be consigned to records after due completion but after waiting for the statutory period of 30 days fixed for restoration. Copy of the order shall go to Additional Deputy Commissioner, Kathua and Tehsildar, Hiranagar for reference and record after the expiry of statutory period of 30 days.
