
ORDER

The present appeal came up for hearing on 03/11/2021. None present from either side. Perusal of the case file reveals that the appellants have filed an application for withdrawal of the instant appeal wherein the appellants have stated that the parties have entered into compromise outside the court and in this view of the matter they do not want to press the case anymore. However, they have not presented any compromise deed before this Court. The statements of the appellants have been recorded wherein they have averred that they have entered into a compromise outside the court and they want to withdraw the case.

After the filing of the application for withdrawal of the case, the parties have chosen to remain absent from the last three consecutive hearings. I have gone through the record placed on the file, it has been observed that the question of appreciation of the matter in terms of the Agrarian Reforms Act is involved in the instant case for which this court lacks jurisdiction. In view of the above, the appeal is dismissed with the liberty to the parties to agitate the same before the competent forum, if they chose so. A copy of the order shall also go to Collector Agrarian Reforms (SDM South Jammu) for information and necessary action under norms.

The stay granted by this court, if any, shall stand vacated. The case file be consigned to records after due completion.
