ORDER

The present case came up for hearing on 07.12.2022. None present for petitioner/appellant and private respondent. ARA appeared on behalf of official respondent and stated that after the filing of the present application for transfer of the appeals, the petitioner/appellant is not appearing in the case. Moreover, the then Additional Deputy Commissioner, Poonch has been transferred and as such the present application for transfer of appeals have become infructuous which may be dismissed. Perusal of the case file reveals that the present transfer application has been filed for transfer of cases (appeals) titled Public at Large through Mohd. Aslam S/o Nazir Hussain resident of Chejla Tehsil Mankote against mutation 891 LB6-C of 1958 and 740 394-C pending disposal in the court of respondent No. 1 to any other court of competent jurisdiction. The petitioner/appellant has not attended the court after filing the present application. During the pendency of this transfer application before this court, it has been informed that the Presiding Officer of the court below against whom the allegations of bias were leveled has been transferred and new incumbent has joined. The court below shall resume the proceedings in the case and decide the same expeditiously after hearing the necessary parties.
