Revision against order 01/2021 dated 17.9.2021 passed by learned Tehsildar Ban Brahmana District Samba passed in case titled Behari Lal & Ors v/s Ravinder Khajuria & Ors with a prayer for setting aside the same.

**ORDER**

The present revision came up for hearing today on 07.12.2022. None present from either side. Perusal of order sheet of the case file reveals that neither the petitioners nor his counsel have been attending the court continuously since 11.05.2022 and today i.e. on 07.12.2022 also they have not caused appearance in the court, from which it is inferred that the petitioners have lost interest to prosecute this case and further hearings in the matter would result in wastage of the precious time of Court. In the absence of parties, court is constrained to return findings on merits. Therefore, the present petition is dismissed in default for non-prosecution on behalf of petitioners. The interim/stay order issued by this court, if any, shall stand vacated. The case file be consigned to records after due completion but after waiting for the statutory period of 30 days fixed for restoration. However it is clarified that this court has not expressed any opinion with regard to the merits of the petition.
