Revision against the order dated 10.03.2020 passed illegally back dated by the Additional Deputy Commissioner Poonch without providing opportunity of being heard to the petitioner in violation of fact and Law and illegally quashed Mutaiton No. 1668 dated 13.02.2014 attested in favour of the petitioner under Govt. Order S/432 of 1966 under Khasra No. 2223 rectified as Kh. No. 2273 situated in village Fazal Abad Tehsil Surankote measuring 8 Kanals in pursuance of orders of Financial Commissioner upheld by the Hon'ble High Court in LPA No. 140/1993 dated 21.02.1994.

Prayer for quashing the order impugned.

ORDER

The present revision petition came up for hearing today on 13.04.2023. None present for petitioner. Ld. Counsel for the respondent No. 1 present. Advocate G.C. Sharma appeared and filed Vakalatnama on behalf of respondent No. 2. Ld. Counsel for the respondent No. 1 stated that petitioner is not causing appearance from last many hearings and the petition may be dismissed in default for non prosecution on behalf of petitioner. Perusal of order sheet of the case file reveals that neither petitioner nor his counsel have been attending the court continuously since 27.07.2022 and on 08.02.2023 an application has been received on behalf of Ld. Counsel for petitioner for adjournment of hearing but today i.e. on 13.04.2023 again they have not caused appearance in the court, from which it is inferred that the petitioner has lost interest to prosecute this case and further hearings in the

matter would result in wastage of the precious time of Court. Therefore, the present petition is dismissed in default for non-prosecution on behalf of the petitioner. The interim order issued by this court, if any, shall stand vacated. The record file of the court below be sent back and the case file be consigned to records after due completion but after waiting for the statutory period of 30 days fixed for restoration.
