Appeal against the mutation order no. 742 passed under section 121 of Land Revenue Act on dated 20-06-1966 with respect to the land underlying Khewat no. 64/29 min., Khata no. 296/192 min / 193 min, Bashra Jhewat no. 01 land falling under Khasra no. 181 (Old) new Khasra no. 1399 measuring 05 Kanal 06 Marlas, Khasra no. 179 (old) new Khasra no. 1399/1 measuring 03 kanal and 02 Marlas and Khasra no 181 min (old) new Khasra no. 1400 measuring 04 Kanal 17 Marlas situated at Maitra – Govindpura Tehsil and District Ramban by the then Tehsildar Ramban which is against the fact and provisions of law.

Prayer for setting aside the same.

ORDER

The present appeal came up for hearing today on 15/07/2021. Ld. Counsel of both the sides present. While arguing the matter Ld. Counsel for the respondent stated that he has not received the copy of the application for condonation of delay. In this regard Ld. Counsel for the appellants stated that he has already attached the same with the appeal. He supplied a copy of the

application to Ld. Counsel for respondent. Ld. Counsel for the appellants pleaded that he wants to produce some documents on the next date of hearing and prayed that leave be granted to file the same, which is granted. Ld. Counsel for respondent prayed that permission be granted in his favour to harvest the crop and also to cultivate the land as he has been shown to be in cultivating possession as per the report of the Tehsildar sought by this Court. He further pleaded that the appellants are unnecessarily interfering into his peaceful possession and prayed for interim direction. Tehsildar shall ensure that party in possession as per enquiry report submitted by him to this Court vide No. TR/OQ/2021-22/Court/276 dated 09/06/2021 shall not be disturbed. Put up for arguments on the application for condonation of delay on 01/09/2021.


