In the matter of :- Appeal against the order dated 17.04.2021 passed in the appeal titled Mohd Kabir and other versus Qasim Din and another by Ld. Trial Appellate Court i.e. Additional Deputy Commissioner, Rajouri with respect to mutation No. 947 of L.B. 6/C and 948 S-432 falling under Khasra No. 1 min measuring 20 kanals situated at village Jamola Tehsil Kotranka, and prayer for setting aside the order dated 17.04.2021 passed by the Trial Court and upheld the mutation No. 947 of L.B. 6/C and mutation No. 948 of S-432 falling under Khasra No. 1 min measuring 20 Kanals which was attested by the Tehsildar Kotranka in favour of the appellant in the interest of justice.

ORDER

The present appeal against order dated 17.04.2021 passed in the appeal titled Mohd Kabir and other versus Qasim Din and another by Additional Deputy Commissioner, Rajouri with respect to mutation No. 947 of L.B. 6/C and 948 S-432 falling under Khasra No. 1 min measuring 20 kanals situated at village Jamola Tehsil Kotranka, and prayer for setting aside the same. None present for the parties. Perusal of the order sheet reveals that nobody is appearing in the instant case since four consecutive hearings, from which it is inferred that the appellant has lost interest to prosecute the matter any further. The continuance of proceedings in absence of appellant / petitioner in the instant case will result in wastage of the precious of the court. In the absence of the parties this court is constrained to adjudicate the appeal on merits.

In view of the absence of the parties, the appeal is dismissed in default for non prosecution on behalf of the appellant / petitioner. The interim order issued by this court, if
