In the matter of :- Revision petition against the impugned order dated 20.03.2018 passed by the Court of Sub Divisional Magistrate with the powers of Collector Chenani in an appeal against Mutation No. 307 dated 12.10.2011 unlawfully attested by Tehsildar Chenani on the basis of a non-existent Will. Hence, setting aside the same.

ORDER

The present petition came up for hearing on 23.11.2022. None present for petitioners and private respondents. ARA appeared on behalf of official respondent. Perusal of order sheet of the case file reveals that neither the petitioners nor his counsel have been attending the court continuously for last three hearings and today i.e. 23.11.2022 also they have not caused appearance in the court, from which it is inferred that the petitioners have lost interest to prosecute the case and further proceedings in the matter would result in wastage of the precious time of Court. Therefore, the present petition is dismissed in default for non-prosecution on behalf of the petitioners. The interim order issued by this court, if any, shall stand vacated. The record file of the court below be sent back and the case file be consigned to records after due completion but after waiting for the statutory period of 30 days fixed for restoration. Copy of the order shall go to Sub Divisional Magistrate, Chenani for reference and record after the expiry of statutory period of 30 days.
