
ORDER

The present petition came up for hearing today on 23.11.2023. None present from either side. Perusal of order sheet of the case file reveals that neither the petitioner nor his counsel have been attending the court continuously after the filing of the petition on 25.07.2023 and today i.e. on 23.11.2023 also they have not caused appearance in the court, from which it is inferred that the petitioner has lost interest to prosecute the case and further proceedings in the matter would result in wastage of the precious time of Court.
