
In the matter of:

Appeal against the order dated 14.09.2019 passed by the Deputy Commissioner, Samba vide No. DCS/Rev/2019-20/48 against the appellants being arbitrary, illegal, untenable in law and against the principles of natural justice and in violation of order dated 29.01.2018 passed by the Hon'ble JandK High Court in OWP No. 1880/2019. Pass any other order which this Hon'ble Court deems fit in the interest of justice.

ORDER

This case came up for hearing on 24/02/2021. Nobody appeared on behalf of the appellant. Ld. Counsel for the respondents present. ARA appeared on behalf of the official respondent. From perusal of order sheet it has been observed that the appellant has not been attending the court right from 12.03.2020 from which it is inferred that the appellant has lost interest in the matter and if the proceedings are allowed to continue it will only result in wastage of precious time of the court. In view of the above facts the case is dismissed in default for non-prosecution on behalf of appellant. The interim order issued by this court, if any, shall stand vacated. The case file be consigned to records after due completion but after waiting for statutory period of 30 days fixed for restoration. The record file shall also be sent back after the said period of 30 days.
