IN THE MATTER OF: Revision petition against the order dated 31.08.2018 passed by respondent No. 1 (Deputy Commissioner) Kathua, in File No. DCK/Reader/346, whereby appeal against the deceased mother of petitioner is accepted and the mutation number 308, is set aside in respect of land measuring  $\frac{3}{4}$  marlas comprising Khasra No. 294/51(old), 228(new) situated at Chak Nathal, Tehsil Hiranagar, (now) Mahreen District Kathua, which is without any jurisdiction, non-application of mind and gross illegalities in passing the order of setting aside mutation No. 308 attested in favour of deceased mother of the petitioner and also remanded the case to Tehsildar Mahreen, for deciding a fresh by conducting denovo enquiry with a prayer for setting aside the order of respondent No. 1 as being illegal and non-est in the eyes of law.

**ORDER**
