ORDER

This present petition came up for hearing today on 25.08.2021. None present from either side. Perusal of the order sheet reveals that no body is appearing in the matter on behalf of the petitioner for quite some time from which it is inferred that the petitioners have lost interest to prosecute the matter anymore. However, perusal of the record annexed with the case file reveals that the land involved in the matter is state land and the court deems it proper to refer the matter to Deputy Commissioner, Jammu for taking the cognizance of the same. Therefore the case is remitted to the Court of Deputy Commissioner, Jammu for further proceedings and disposal under law in the matter, keeping in view the status of the land and interest of the state. A copy of the paper book of the petition be sent to Deputy Commissioner, Jammu alongwith copy of this order. The status quo order issued by this Court shall remain intact till the case is taken up by the Deputy Commissioner, Jammu. The case file be consigned to record after due completion.
