**ORDER**

The present petition has been filed u/s 30 of Big Landed Estates Abolition Act 2007 Bk read with Section 15 of Land Revenue Act 1996 Bk against a mutation attested u/s 4 by the respondent 2 by virtue of which the land of petitioners comprising of Khasra 2 min, 3 min and 32 of Village Bagey, Tehsil Jammu (Now Tehsil Dansal) has been mutated in the name of the State and for setting aside the same. This case came up for hearing on 29.09.2022 and none present from the either side. The case file was examined and after careful examination of the case, it has been observed that the present revision petition has been filed under Section 30 of Big Landed Estates Abolition Act 2002 Bk. In terms of SO-3808 (E) dated 26.10.2020, the Big Landed Estates Abolition Act has been repealed and as per Section 140-(2) inserted vide S.O. 3808 (E) dated 26.10.2020 of the Jammu and


