ORDER

26-07-2021:- This case was transferred from the court of Ld. Divisional Commissioner, Jammu to this court. The case was heard in depth on 12.07.2021 and 26.07.2021. Counsel for nonapplicants stated that prayer of the applicant was only to transfer the case from the Court of Assistant Commissioner (Revenue), Poonch to any other Court on the ground that the presiding officer is biased. Now since the then Presiding Officer has been transferred and new incumbent has taken over the charge of Assistant Commissioner (Revenue) Poonch, this application has become infructuous. The counsel for the applicant raised no objection.

In view of the above submission made by the Counsels before this Court, the transfer application has become infructuous and is as such disposed off with the remarks that the Court of Assistant Commissioner (Revenue), Poonch after following due process of law, shall decide the matter on merits strictly in accordance with the law/Rule governing the subject matter. File be consigned to records after due completion. The stay order, if any issued by this Court, is vacated. A copy of this order is forwarded to Assistant Commissioner (Revenue) Poonch alongwith record file as received from office of the Deputy Commissioner Poonch.
