**In the matter of:**-(i) Appeal against the claim prepared by the office of Provincial Rehabilitation Officer, Jammu i.e Respondent No. 1 by virtue of which respondent No. 3 was figured at S.No. 9913 dated 01.11.2017 in the website of the office of respondent No. 1 in the list of the claimants under Prime Minister Development Package of 1947 PoJK Refugees.  
(ii) for appropriate directions to the respondent No. 1 & 2 for stoppage of the aforesaid claim as the same has been procured by means of false and fabricated documents as against the provisions of law

**ORDER**


The present appeal has been transferred from the Court of Ld. Divisional Commissioner, Jammu to this court. The appellant has filed appeal against the claim prepared by the office of Provincial Rehabilitation Officer, Jammu i.e Respondent No.1 under Prime Minister Development Package of 1947 PoJK Refugees. The case came up for hearing on 21.03.2022. None present from either side.

In para-4 of the writ petition, the appellant has also submitted that "*the claim of said Smt. Koushalya Devi has been challenged by Smt. Sadro Devi in the Court of Learned Sub-Judge, Jammu who has passed an interim order and the case is subjudice.*"

Perusal of order sheet reveals that the appellant has not been attending the court for many hearings from which it is inferred that the appellant has lost interest to prosecute the case. Further continuance of proceedings in the instant case would only be wastage of time to this court. Hence the appeal is dismissed in default for non-prosecution. The interim order, if any, issued by this court shall stand vacated. The file be consigned to records after due completion.
