To restrain the non-applicants from illegally and unlawfully selling the land comprising Khasra No.98,101,102 and 105 situated at village Dabbar Tehsil Nowshera.

## ORDER

30.10.2021.

The applicant filed the petition/complaint before the court of the Divisional Commissioner, Jammu which was transferred by Divisional Commissioner, Jammu and directed to be listed before this Court. The perusal of the file reveals that, the then Additional Commissioner, Jammu, vide order dated 17.12.2019 issued notice to the other side and directed Tehsildar Nowshera to further direct Naib Tehsildar concerned to appear before this court along with the relevant record pertaining to the Khasra numbers in question, on 14.01.2020.

The applicant has neither filed an appeal nor revision petition against any order. He has simply come up with a complaint, requesting therein to restrain the non-applicants from illegally and unlawfully selling the land in question. Besides, the applicant has also mentioned in the complaint that Khasra No. 105 is a state land which the non-applicants are trying to sell.

The appropriate course of action in the matter is that the Tehsildar Nowshera shall enquire in the matter and take appropriate action under law/norms. Accordingly, the complaint of applicant is disposed of, with the direction that Tehsildar Nowshera shall enquire into contents of the complaint and dispose of the same strictly in accordance with Law/rules governing the subject matter, after giving due opportunity of being heard to both the parties. Tehsildar Nowshera shall also enquire into the allegations, whether any person as mentioned above, is trying to encroach or sell the state land and shall proceed strictly as per law/ rules. The reader shall provide a copy of the order to Tehsildar Nowshera alongwith the copy of complaint of applicant .The file be consigned to records after due completion.
