In the matter of:-Revision petition against the Deputy Commissioner (District Collector) Kishtwar's order dated 18/12/2019 in file number 11/DCK/misc titled as Sadhu Ram and others versus Neema Devi and others whereby the DC Kishtwar has accepted the appeal of the appellant and order passed by Tehsildar Drabshalla with respect to mutation number 129 dated 1/2/2017 of revenue village Shandari of Tehsil Drabshalla has been set aside.

ORDER

The petitioner has filed this petition before the court of Divisional Commissioner Jammu which has been transferred to this court for further proceedings. File presented for hearing on 29.03.2022. Parties called. Petitioners as well as Ld. counsel for the petitioners absent. Perusal of file and order sheet, reveals that neither the petitioners nor their counsel is appearing in this case from many hearings. It appears that the petitioners are not interested to pursue the case. The matter cannot be decided on merits due to non-appearance of the parties. Further continuance of proceeding in the instant case would only be wastage of time of this court. As such the court is constrained to consign the case to records. In view of above, the revision petition is dismissed in default due to non prosecution of the case. Interim direction/order if any, issued by this court shall stand vacated and file be consigned to records after due completion.
