Whereas, vide this office order No. DIVCOMJAMU(ESTT) 38 OF 2017 DATED 07.12.20217, Mohd. Rafiq, Patwari (District Cadre Udhampur) was transferred and placed at the disposal of the Chief Engineer, Jal Shakti (Irrigation & Flood Control), Department, Jammu.

Whereas, Chief Engineer, Jal Shakti (Irrigation & Flood Control), Department, Jammu vide letter No. IFCJ/8681-83 dated 23.08.2021, has reported that Mohd. Rafiq, Patwari (Revenue Department) presently working in his organization was absent from duty w.e.f. 16.08.2021 and his whereabouts are not known to him.

Whereas, Chief Engineer, Jal Shakti (Irrigation & Flood Control), Department, Jammu has further reported that as per wireless message received from Sr. Superintendent of Police, Crime Branch, Jammu vide No. CBJ/OW/21/20533 dated 18.08.2021, Mohd. Rafiq (Patwari) S/o Sh. Bashir Ahmad R/o Satwari has been arrested on 16.08.2021 at 15.44 Hrs. and FIR has been lodged against the official under No. 72/2016 U/S 420, 465, 467, 471 120-B RPC 5(2) PC Act of P/S Crime Branch, Jammu.

Therefore, in view of the above facts, Mohd. Rafiq, Patwari (District Cadre Udhampur) is hereby repatriated from Irrigation & Flood Control, Department, Jammu and placed at the disposal of Deputy Commissioner, Udhampur.


Further, Deputy Commissioner, Udhampur shall get the matter enquired and take appropriate necessary action under rules.
