**DATED 02.09.2021**


The post of Patwaris is a District Cadre post and as such, they are to be posted within the territorial limits of their parent district. However, some Patwaris had been transferred in the past from their parent District to another District in violation of rules and directions issued by the Government vide Govt. Order No: Rev(NG) 52 of 2015 date: 09.03.2015; and thus have to be repatriated to their parent district/ cadre; as the work in the Districts where from the Patwaris have been transferred is getting adversely affected. Accordingly, the below mentioned Patwaris working outside the district/ cadre are hereby repatriated to their parent district/cadre and are deemed to be relieved forthwith, with the directions to report to the respective Deputy Commissioners of their District Cadre for further postings:-
