Minutes of Meeting held on 06.09.2021 at 3:00 PM under the Chairmanship of Dr. Raghav Langer, IAS, Divisional Commissioner, Jammu in his Office Chamber regarding OWP No.1280/2004 titled J&K All India Taxi, Sumo, Tempo Union & Anr. V/s State of J&K & Ors.


The following officers participated in the meeting:

1. During the course of meeting the chair has been briefed about the contention raised by the J&K All India Taxi, Sumo, Tempo Owner's Union with regard to the handing over of two remaining sites ISBT Transport Nagar Narwal, Jammu and site opposite Divine Lodge Trikuta Nagar, Jammu in pursuance of the Hon'ble High Court directions dated 10.07.2017 and also in light the report and recommendations of High Powered Committee.
2. After threadbare discussion and available record, following directions has been issued:
 - i) Committee headed by Transport Commissioner, Jammu, along with Vice Chairman, Jammu Development Authority, Jammu, Additional Deputy Commissioner (Adm), Jammu and Assistant Commissioner, Jammu Municipal Corporation, Jammu along with members of J&K All India Tax, Sumo, Tempo Owner's Union shall visit both sites viz a viz ISBT Transport Nagar Narwal, Jammu and site opposite Divine Lodge Trikuta Nagar, Jammu and submit their recommendations with regard to feasibility of sites to be declared as Taxi stands.
 - ii) During the course of meeting J&K All India Taxi, Sumo, Tempo Owner's Union was asked to identify any other spot/area, which will be inspected by the same team headed by Vice Chairman, JDA, Jammu as detailed above and on the basis of the report with regard to the feasibility the spot/area, the same can also be considered for declaration as Taxi Stand.

- iii) During the course of meeting Taxi stand union has also raised the issue of encroachment at Amphalla taxi stand and to this effect the chair has issued directions to Addl. Deputy Commissioner (Adm), Jammu to visit the spot personally and remove such obstructions/ encroachment, if exists on spot.
- iv) During the course of meeting a general instruction was issued to the authorities to ensure no encroachment of pathway or road within Jammu city specially at B.C Road, Jewel area, Amphalla including crowded area and encroachment if any, should be removed forthwith.

The meeting ended with the vote of thanks to the chair.
