Minutes of the meeting held under the Chairmanship of Dr. Raghav Langer (IAS) Divisional Commissioner, Jammu on May 25th, 2021 to review the status of Civil Works / Provisioning of Power Supply/ Power Backup/ manifold & Medical Gas Pipe line System for oxygen Generation Plants to be commissioned in Districts of Jammu Division. Following officers participated in the meeting.

Worthy Divisional Commissioner, Jammu welcomed the participants attending the meeting and reviewed the existing capacity of Oxygen Generation Plants already installed/ to be installed by Mechanical Engineering Department/ under PM Care Fund/by JK ERA.

The Chair requested all Deputy Commissioners of Jammu Division, Chief Engineers PWD/ERA Superintending Engineer (Mechanical), Executive Engineers and other concerned officers to gear up their efforts at all levels and prepare the **Detailed** Project Reports within 2 days and submit it to Health and Medical Education

Department with the copy of the same to this office.

At the outset, all Deputy Commissioner were apprised by Divisional Commissioner that oxygen Generation Plants from three sources have been approved pr various Health Institutions in Jammu Division i.e. under regular allotment through lechanical Engineering department, allotment of oxygen generation Plant under PM cares, Govt of India allotment and oxygen generation Plant sanctioned by JK ERA and JTFRP. The Divisional Commissioner clarified that JK ERA has allotted works on turnkey basis and accordingly for JK ERA Projects, all civil /Electric/manifold/Pipeline/ oxygen generation Plant related works shall be carried out by designated contractor of JK ERA and in such cases only appropriate site within hospital premise to earmarked by Wolstrict administration/ Health authorities, for allotment made under PM Care/ GOI special allotment, apart from Oxygen Generation Plant, it has been made to understand that only civil works related to Plant room shall be carried out by agency designated by GOI and accordingly other allied works, viz; transformer, Digi set, oxygen manifold, manifold gas line pipe system etc is to be provisioned for by UT authorities.

Deputy Commissioners were directed to prepare DPRs on their lines for generation Plant approved under PM cares/ GOI allotment on similar lines.

Similarly, since it is being observed that in majority of cases where Oxygen Generation Plants are being installed by Mechanical Engineering Department under regular allotment, provision for oxygen manifolds and extension of Gas pipe lines system has not been kept by Mechanical Engineering Department. Thus in such cases, the directions were issued to Deputy Commissioners to prepare DPRs so that new oxygen capacity can be put to actual use by Hospital Authorities for optimal patient

The details of allocations made under above mentioned heads is hereby enclosed as Annexure "A"

The Chair directed Deputy Commissioner Samba to prepare 2 nos of DPRs, one for optimal utilization of existing oxygen generation plant and one for all civil works to be done for one more plant sanctioned under PM CARES. She was further directed to identify the site for the Oxygen generation plant to be installed by ERA.

Deputy Commissioner Kathua was solicited for identification of the space for installation of Oxygen generation Plant by ERA at Hiranagar, Basohli, Bani and also prepare DPRs depicting plan for Civil Works / Provisioning of Power Supply/ Power Backup/ manifold & Medical Gas Pipe line for approved Oxygen generation plant by Mechanical Engineering Department and approved under PM CARES/ GOI allotment.

Deputy Commissioner Jammu has been directed to formulate,

- 1) 2 nos of DPR's one for new Emergency Block under regular allotment depicting manifold work/ gas pipeline system and the other DPR for Oxygen Generation Plant in the existing block under PM CARES for GMC Jammu.
- 2) 2 nos of DPR's, one DPR for the manifold works/Gas pipeline system for existing oxygen generation Plant and the other DPR for the oxygen generation Plant to be sanctioned under PM CARES fund at Disease Hospital for making the system functional. Chest
- 3) DPR for existing Oxygen Plant in Government Hospital Gandhi Nagar depicting manifold works / Gas Pipe line system, if required for optimal
- 4) 2 nos of DPR's for Government Hospital Gandhi Nagar Maternity Care Hospital, one for plants under installation and other sanctioned under PM
- 5) 2 nos DPR's for Super Specialty Hospital for oxygen generation plant under installation by Mechanical Engineering Department and the other Oxygen generation plant to be sanctioned under PM CARES Fund.
- 6) DPR for Manifold / Pipe line for the Plant room for Government Hospital
- 7) DPRs for the extension of Pipeline for the existing Oxygen Generation plants under PM CARES Fund at Kot Bhalwal Hospital & Rajiv Gandhi Hospital Gangyal and also directed for identification of site for Trauma

Deputy Commissioner, Poonch was directed to identify the Sites for the bygen Generation Plant to be installed by the ERA at Surankote and Mendher and also prepare 2nos of DPR's, one for the oxygen generation plant which is going to be installed by Mechanical Engineering Department and other under PM CARE Funds for District Hospital Poonch. On the parameters mentioned above He has been directed to prepare DPR for the oxygen generation plant by Mechanical Engineering Department at Sub District Hospital Mandi.

Deputy Commissioner, Kishtwar was directed to prepare 2 nos of DPR's, one for the Oxygen generation plant to be installed by Mechanical Engineering Department and 2nd one under PM CARES Funds for District Hospital Kishtwar.

Deputy Commissioner, Doda was directed to prepare 2 nos DPR's; one for the Oxygen generation plant to be installed by Mechanical Engineering Department and another by PM CARES Fund for Government Medical College, Doda. Deputy Commissioner Doda was also directed to prepare DPR for oxygen generation plant for Bhaderwah also.

Deputy Commissioner, Reasi was directed to prepare 2 nos DPR's, one for the existing Oxygen generation plant for up gradation and one under the PM CARES and also to identify the site for the installation of Oxygen Generation Plant along with manifold system at Katra to be installed by JK ERA.

Deputy Commissioner, Ramban was directed to prepare 2 nos DPR's, one for the oxygen generation plant to be installed by Mechanical Engineering Department and the other under PM CARES Fund at District Hospital, Ramban. He was also directed to identify the site for the installation of Oxygen Generation Plant along with manifold system at CHC Ramban and Emergency Hospital, Batote by JK ERA.

Deputy Commissioner, Udhampur was directed to prepare 2 nos DPR's, one for the Oxygen generation plant to be installed by Mechanical Engineering Department and other under PM CARES Fund and also asked to identify the site for the Oxygen Generation Plant to be installed by JK ERA for CHC Chenani and submit it to Health and Medical Education department and to follow on regular basis for making the system functional. On the request of DC Udhampur, the chair directed to get DPR prepared for installation of Oxygen generation Plant at Ramnagar.

The Chair requested the Deputy Commissioners of Jammu Division and line departments to follow the directions in letter & spirit; expedite the process of preparation of DPRs and their submission to Health and Medical education department
