Sub: - Record note of the meeting regarding review of Essential Services in Jammu Division.

A meeting was held under the Chairmanship of Sh. Ramesh Kumar, IAS Divisional Commissioner Jammu on 27th of May 2022 at 3:45 PM in the conference hall of Divisional Commissioner Office Jammu regarding the review of various essential services in Jammu Division.

The following officers attended the meeting in person-

1. Chief Engineer I&FC Jammu.
2. Chief Engineer JPTCL, Jammu.
3. Chief Engineer JPDCL Jammu.
4. SE PW(R&B) Jammu-Kathua Circle representing CE PW(R&B) Jammu.

At the outset, Chairman welcomed the participants and focal point of the meeting is to ensure the uninterrupted essential services in Jammu Division so that the public shall not face any inconvenience especially during this summer season.

The up-dated status report from the concerned Chief Engineers has been discussed in details for the whole Jammu Province regarding availability of buffer stock of various utilities, functioning of various stations, availability of manpower and machineries etc and accordingly the following decisions were taken:-

Decisions/Directions-

1. Chief Engineer Distribution shall ensure the uninterrupted power supply apart from the scheduled power cuts required due to shifting of utilities and repair/ maintenance work. He also ensure that the frequent/ prolonged power cuts shall be avoided as it creates hue and cry from the general public especially in this heat wave and also affects the economic activities.
2. Chief Engineer Distribution shall personally ensure the supply of transformers, poles and conductors especially at far-flung area of the Jammu Division for any exigency.
3. Chief Engineer Distribution shall ensure that all the transformers workshops in the Division are functional properly.
4. Chief Engineer Transmission shall look into the issue of water logging in STD Mendhar, which were raised by the local public during the visit of worthy Divisional Commissioner in District Poonch.
5. Chief Engineer Distribution shall expedite the process of installation of Smart Meters in Jammu City on priority.
6. Chief Engineer Distribution shall look into the problem raised by people of border area of Kathua district regarding power supply through Sarna-




Kathua line which generally disrupted and take immediate necessary measures for its permanent restoration.

7. Chief Engineer Distribution shall take appropriate arrangements in advance as per the weather advisory issued by metrological Department Gol due to frequent western disturbances approaching J&K causing hailstorms, strong winds, heavy rains causing disturbance in power supply.
8. Chief Engineer I&FC shall make proper distribution of canals water supply to the farmers till tail end of the canals in Jammu Division for the upcoming season of Kharief crops so that the farmers will get adequate water supply to their crops for quality production.
9. Chief Engineer I&FC shall make appropriate arrangements to tackle floods in advance for the up-coming monsoon season by putting men, machinery and material to the vulnerable areas and also arrange meetings with the stake holders and activate control room at Divisional/ District level.
10. Chief Engineer I&FC shall expedite the progress of Tawi Barrage Projects on priority keeping in view the ongoing progress of Tawi River Front Development Project.
11. Chief Engineer PW (R&B) Jammu shall expedite the maintenance work of roads and filling of pot holes on priority especially in Jammu city due to heavy load of commuters and also ensure to improve the condition of roads/bridges of Jammu Division prior to SANJY -2022.
12. Chief Engineer PW (R&B) Jammu shall personally ensure the progress of works taken up under NABARD as public is approaching time and again with the problems/complains under this sector.
