Sub:- Record note of the meeting regarding review of the progress of road connectivity linking various temples near Bhawe Wali Mata.

A meeting was taken by Sh. Ramesh Kumar, IAS, Divisional Commissioner Jammu on 22nd September, 2022 at 11:00 AM in the conference hall of Divisional Commissioner, Office Jammu to review the progress of road connectivity linking various temples near Bhawe Wali Mata. At the outset, the Divisional Commissioner Jammu welcomed the participants; the focal point of the meeting was to review the progress for road connectivity, linking various temples near Bhawe Wali Mata, Sanitation and drainage system thereof. Chair showed dismay over worst condition of the roads in Jammu city, Poor sanitation work in entire city etc and it was stressed to Repair and Maintenance of roads of Jammu city in wake of upcoming Navratra festival, and Darbar Move and ensure proper sanitation. After detailed deliberations on the various issues and to expedite the work of macdamization and filling of potholes on priority basis so that, the common masses especially yatries approaching Bawe Wali Mata Temple during the festival of Navratra shall not face any inconvenience. Accordingly, the following decisions are taken:

- 1) Commissioner, Municipal Corporation, Jammu shall finish the repair and maintenance work of road from Ropeway to Shri Ravi Dass Temple by 24th of September 2022.

- 2) Superintending Engineer, Jammu-Kathua-Samba circle shall ensure the completion of various ongoing works of repair and maintenance of roads in Jammu city such as University road, Bus Stand road, Gujjar Nagar road and other allied roads on priority basis and ensure their completion within stipulated time period.

- 3) It was observed by the Commissioner, JMC, Jammu that during bush cutting by JDA and PW(R&B), authorities, the bushes and shrubs are being dumped on road side causing inconvenience to the general public and commuters. It was stressed that both the agencies shall lift these shrubs/bushes to identified site of dumping shrubs and bushes at Kot Bhalwal, Jammu.

(Action by: VC JDA, and SE PW(R&B) Jammu-Kathua-Samba circle)

- 4) Commissioner, JMC, Jammu shall ensure proper sanitation/ cleanliness in entire Jammu city with cleanliness of drains , installation of dust bins, lifting of garbage, judicious use of compactor at Bhagwati Nagar, Jammu so that the dumps of garbage outside are not visible which gives a shabby look. Besides, all the garbage dumping sites of the city shall be covered with the help of flexes as view cutter so that the city should look neat and clean. Moreover, Health officer, JMC, Jammu shall ensure regular on spot visits to the entire city and monitor proper cleanliness and sanitation personally including fogging etc and submit a daily report to the Commissioner, JMC, Jammu on this account.

- 5) The DPR for the repair and maintenance of road connectivity including protection work towards Harki Pochi shall be completed on priority and the work shall be started soon after the culmination of Navratra festival.

(Action by Commissioner, JMC, Jammu)

- 6) The protection work, footpaths, and drainage work at Bawe Wali Mata Temple road shall be taken up only after the culmination of Navratra festival to avoid any inconvenience to the yatries.

(Action by Commissioner, JMC, Jammu).

- 7) Vice Chairman, JDA, Jammu intimated that the parking complex near the Bawe Wali Mata Temple has been completed in all respect and as on date there are three main parking complexes available around the temple. In this context, it was directed that SSP, Traffic, City, Jammu shall organize and make judicious use of these parking complexes during the Navratra festival so that there will be no traffic jamming and the same shall be monitored by Deputy Commissioner, Jammu who shall also convene a meeting on this account.


